


Sir,

I have the honour to state that, On 04-05-2023 at around 3:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 400 persons carrying deadly weapons committed an Anti Social elements , at Abung Workshop at Leitanpokpi Village , Imphal East District, Manipur, about 12 km South from Saikul PS.


That, my Santro (Silver colour) bearing Regd. No. MN05A8886 which was repair at Abung Workshop at Leitanpokpi Village , have been totally burnt down to ashes after removing and looting all the serviceable parts, including important documents etc. The approximate value of burnt down Vehicle is calculated at about Rs. 3,00,000/- (Three lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.


