I the undersigned have the honour to state that, the under noted domestic animals of our village were usually grazing at the grazing ground of Wakanphai Kuki village and not yet returned since 3rd May, 2023 and due to present ethnic violence between Meitei Community & Kuki Community the missing domestic animals could not be trace out till date. From our relatives / friends, it is learnt that, the undernoted missing domestic animals were ~~stole~~ from Sadulampak Grazing ground by the unknown armed Kuki militants and killed for beef.

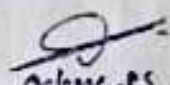
