Sir,

With due respect, I, the undersigned have the honour to report that today i.e 04/12/2023, conducted Cordon and Search Operation (CASO) by a combined team comprising of CDO Imphal East, two teams of Sagolmang PS, 18 AR (3 Officers, 2 JCO & 35 Ors), 32 AR (1 Officer, 1-JCO & 15 Ors), OC/CDO -Imphal East assisted by SI Md. Khalilur Rahaman, under the supervision of Shri. Dr. S Ibomcha Singh, MPS, Superintendent of Police, Imphal East in areas namely Hill ridge line of Nongshum and Khamenlok Village, under the jurisdiction of Sagolmang Police Station under Sagolmang PS, Imphal East District from 9:30 am to 02: 30 pm.

In the search operation, the combined team cordoned and searched at the above mentioned areas. In that, the combined team detected 2(two) Plastic bags which was found concealed under bushes at the general area between Khamenlok and Nongshum. On checking the said bags, the following incriminating items were found.

- (1) One SMG Carbine bearing Regd. No. 18251252 with one empty magazine.
- (2) One SMG Carbine bearing Regd. No. 15228653, Butt No. 148 with one empty magazine.
- (3) One SMG Carbine bearing Regd. No. 16200912 with one empty magazine.
- (4) 15 (fifteen) Nos. of HE 36 Hand Grenade without Detonator.
- (5) 6 (six) Nos. of WP Smoke Grenade without Detonator
- (6) 18 (eighteen) Nos. of 2" Motor HE Bomb &
- (7) 6 (six) Nos. of No. 75 MK-2 Detonators.

So, the above listed items were seized from the spot i.e at the general area between Khamenlok and Nongshum at 2:10 pm by observing necessary formalities in presence of witnesses.

Therefore, the seized incriminating items are being handed over to you for taking up further necessary legal action.
