Sub: - Complaint report of vandalizing, looting of properties and burning down of my house at Chassad Avenue, Imphal East district, Manipur - regarding.

Sir/Ma'am,

I, the undersigned Ms. Alhing Haokip W/o T. Sheilam Haokip, having a permanent resident at Chassad Avenue, Imphal East district under **Porompat Police Station, Manipur** and staying at Govt. Quarter No. 7/Type-V (CP) Lamphel, near Lamphel Police Station, Imphal West-795 004 would like to file a complaint/report.

That since 3rd May, 2023 communal persecution swept across Imphal and parts of Manipur leading to a grave loss of lives and widespread destruction of personal and public properties.

That, on the 4th May 2023, our house situated at Chassad Avenue, Imphal East district - a stone throw distance from Chief Secretary's Quarter and DGP's residence, was ransacked, looted and set ablaze by the Meitei mob, mostly wearing black T-shirts, suspected to be members of Arambai Tenggol, Meitei Leepun and others. It is reported that the looting continued for many days after the arson on 4/5/2023.

The detailed descriptions are given as under:

This horrible incident has had a profound impact on our lives and we feel violated and unsafe in our own homes and I hold the authorities responsible for not providing adequate security measures to prevent such gruesome attacks from occurring. The lives of tribal Kukis being targeted we were forced to leave Imphal for safety. However, there was no security arrangement for travelling to the hill districts at that time. We, therefore rushed to the Imphal Airport and fled to Guwahati on 06.05.2023 and took shelter here for now.

I, therefore, request you for registration of a **Zero FIR** as we cannot go home to file a complaint due to the prevailing law and order situation in our State, Manipur.
