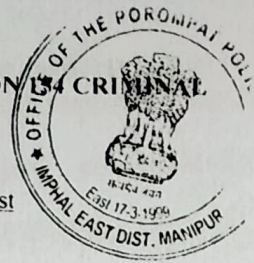
Sir,
