Subject – **Report on vandalism and looting of properties.**

Sir,

I am to bring to your kind notice that I am a Scheduled Tribe (Kuki) and a resident of Chassad Avenue, Pureiromba Leikai, Porompat Sub-Division, Imphal East District.

That, on the 7th May, 2023 at 11:30Am. My above said residence (Owned) was attacked, partially destroyed, looted by a Group of Meeitei/Meitei radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property from my "Owned" House, and premises worth Rupees Three Crores Thirteen Lakhs (Approx.).

The following are the list items destroyed or looted by unknown miscreants:

1. Standing Building (Pucca) Partially damaged worth Rs 2 Crores.
2. Ornaments and Jewellery Worth Rs.4 lakhs.
3. Cash amounting to Rs. 4 lakhs.
4. Electronics and Accessories worth Rs.15 lakhs.
5. Household items and furniture worth Rs. 20 lakhs.
6. Others movable and immovable assets.

That, while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti-tribal slogans like- "HAO HATLO", "KUKI HATLO", "KANGLEIPAK YAI PHARE", etc. Hence, the same can be taken as an insult on me and my family for being a tribal.

In this regard, I request you to kindly take strong actions against the perpetrators by registering **Zero FIR** under relevant sections of the statutes of our country.
