Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified group of people belonging to kuki community with deadly weapons and sophisticated arms including kuki Militant Groups stormed to all Meitei inhabited areas of Moreh town on 26/7/2023 from 10 am till 4:30 pm. The said unidentified groups vandalized / burnt down my house and looted all valuable items. In the unfortunate incident, I have lost a total amount about Rs. 3500000/- (Rupees thirty five lakhs) Approx. That incident was begin from 3/5/2023. So, I and my all family members are taking shelter at relief camp (Ideal Girls College) situated at Akampat Imphal East District, Manipur. That, the incident was happen while I and my family were staying at the said relief camp.

It is, therefore, requested to kindly take necessary legal action against the accused persons and the persons involved in the said inhuman acts and heinous crime according to law.
