That it worthwhile to submit here that during the regime of all the previous Governments in the State of Manipur, there were no process of identification of illegal immigrants, prosecution against large scale destruction of poppy cultivations, large scale seizure of narcotics substances, and eviction of illegal encroachments in forest area in the State of Manipur. But since the month of March. 2017 the present Government started identifying illegal immigrants from Myanmar and other countries, who are mostly labourers who were brought in Manipur by big investors business man in narcotic substances by the forming a huge. Many leaders of the Kuki militants are the direct beneficiaries of these cartel and poppy is one of the main sources of terror funding of these Kuki terrorists who have mostly come from Myanmar. Therefore, large scale a destruction of poppy plantations in the hill range measuring over 8000 acre; seizure of narcotic substances during last five (5) years; crackdown against Myanmarese immigrants, eviction of encroachments in forest areas are some of the main reason as to why these Narco-terrorists are up in arms against State Government of Manipur and all these Narco-terrorists have been instigating the innocent Kuki community to attack against the Meitei villages in foot hills of across all Districts. Moreover, strict actions are been taken up by the present BJP led State Government against all the illegal encroachments in reserve and protected forest area across all communities including both the Meiteis/Kukis and also numerous actions have been taken against illegal constructions in Paddy Field stringently. These are also the main reasons for the violence being instigated by the vested interested people as many illegal immigrants have started settling in the reserve and protected forest area after they ran away from the Myanmar military crack down within the last 3-4 decades. And the modus operandi of the illegal immigrants is that immediately after illegal settlements in interior part of forests, they will forthwith start poppy cultivations as a main source of livelihood under the finance and control of these Kuki militants.

It is also widely reported in the media that one of the Kuki Chin Minister who was the Chairman of cabinet Sub-Committee for identifying the Kuki immigrants from Myanmar along with his team visited Churachandpur District on 01/04/2023 and then Chandel District on 29/3/2023 and in its first round/initial survey more than 2,100 illegal Myanmarese Kuki immigrants were dictated and these have caused panic to large number of Kuki immigrants in Churachandpur. However, interestingly the said Shri Letpao Haokip within about 45 days therefrom has demanded for a separate administration. Therefore, it is very apparent that there is huge nexus between all of these accused with armed militants, politicians etc., and it has to be investigated.

We must also recall the information made available to the public by State Government officials that the previous State Government only destroyed 66 acres of illegal poppy cultivation in Manipur from 2013 to 2016. But, the present State Government under the leadership of Shri N. Biren Singh destroyed 18,664 acres of illegal poppy cultivations from 2017 to March, 2023. And precisely more than 2699 acres of illegal poppy was destroyed in Churachandpur alone and as such armed narco-terrorist and their supporters based in Churachandpur has every reason to wage war against the State.

Myanmar Government has issued a statement dated 15th June, 2023 that the illegal immigrants of Myanmar who are at Manipur should refrain from doing any acts that are prejudicial to sovereignty and territorial integrity of India. Further, such notification was published by the prestigious newspaper the "Hindu" on 18/05/2023 are enclosed. Therefore, the factual aspect of large scale immigration from Myanmar including armed militants to Manipur for illegal purposed is proved beyond any doubt.

7.1 It is pertinent to mention herein that the border between Myanmar and Manipur is unfenced and left open since border fencing is completed only to the extent of about 10 kms, hence, a stretch of about 390 kms of Manipur-Myanmar International Border still remains porous and easily penetrable for illegal activities such as entering of illegal immigrants, illegal arms smuggling, illegal drug smuggling and such other anti-national activities.

7.2 Further, the Kuki National Army (KNA) has established in Myanmar since 1988 thereby demanding homeland for the kukis, and they were targeted by Myanmar Army and because of such reason they were even bombed and large number of them crossed the unfenced/open border and came to Manipur where they indulged in illegal activities in the Manipur's border region and beyond and also participated in drugs business, bringing of large number of illegal immigrants into the State etc. It is worth mentioning that the said KNA, KNO and other such illegal Kuki outfits operating in the Myanmar came easily through the porous border and gets easily mingled with indigenous Kuki citizens of Manipur residing in Churachandpur, Kangpokpi, Tengnoupal etc. since many of them belongs to the umbrella of Kuki-Chin community, and the said community is residing largely Myanmar, Bangladesh and India they are found in Manipur and Mizoram, Hence, after 1988 the North-East especially Manipur become a breeding ground for such illegal armed outfits after 1990s.

Another, threat to the State is demand for a Kuki homeland which can relates back about 20 years and it is worth mentioning that in Manipur most of these armed Kuki militants were formed to counter the counter part of Naga community after the Kuki-Naga Clashes in 1993-1994 but now due to all these selfish ideologies they have started demanding for separate State/UT or otherwise Kuki land or Zale'n-gam.

Zale'n-gam is one of the major ideologies shared by most of the separatist Kuki-chin militants who instigate innocent people belonging to Kuki-chin-zo community to demand for a single country which comprises of different parts of Myanmar, Bangladesh, Mizoram, some part Manipur, Nagaland etc. And, the instigation and propagation of both the accused which is prima-facie apparent from their statements for the cause of Zale'n-gam creates a serious doubt about the unholy nexus between both the accused and the armed Kuki militants and as such their involvement in anti-national activities cannot be ruled out and it must be investigated.

Therefore, the statement of the accused No. I that the communal violence started on May, 3rd from the Imphal Valley by the Meitei Community is totally false and such false statements have been made to promote enmity between different communities of Kuki and Meitei. The very statement of the accused No. I is reproduced hereunder for easy reference.

"...And it just recalled back the time when the violence started on 3rd of May, it started in the Imphal valley where the ethnic cleansing of Kuki have started and they have they didn't go on their own they have been chased away and I can say that those people who have been displaced from the Imphal valley are the lucky one and lucky survivor who have been sheltered in Army Camp. So, I in this regard, I would like really like to thank the Indian Army. They are the only survivor who have been rescued by the Indian Army."

The Accused No. 1 further stated that by quoting the statement of Mr. Hanshing (Accused No. 2) and Vungzagin Valte's wife that "The Meiteis the Meiteis militants, the State sponsored militants are like wolves. The mob are like wolves and they are like animals." The acussed No. 1 further goes with a serious statement that "Because this war which has been declared by the Chief Minister against the Kukis or the pre-plan ethnic cleansing or genocide of the Kukis have let to the youths holding guns instead of books."

It is a well known fact that the present situation in the State of Manipur has started from the Churachandpur District after the rally turned violent on 3rd May 2023 as evident from the supporting documents. It is also a well known fact that the present situation has been created by armed Kuki Militants against the State Government policies namely (i) crack down against illegal immigrants from Myanmar; (ii) large scale destruction of illegal poppy plantations in the different hill districts including Churachandpur, (iii) war on illegal drugs declared by the State Government; and (iv) eviction process against illegal encroachers reserve forest area. The reasons for the present situation in Manipur have been numerous but the reason assigned by the accused No. 1 is only for demanding status of schedule tribe by the Meitei community and it is completely false. The present Chief Minister only took different steps as stated above to protect the interest of the indigenous people of Manipur (including the kuki tribe who were settle officially in Manipur for over 200 years) and also in the interest of National security.

Therefore, the inflammatory statement of the accused that the Chief Minister has declared war on kuki is destined to encourage the communal tension and killings of innocent meiteis by the Kuki militants.

It is further respectfully submitted that at present the violence is cornered only with the killing of Meitei civilians and village defence force by the armed Kuki Militants. The very statement of the Accused No. 1 is very serious as it amounts to not only instigating the Kuki militants but also Kukis civilians to take arms in their hands against the innocent meiteis villages which is a very serious offence and as the result of the statement by both the accused many Kuki people all across the districts have started attacking and burning Meitei villages because of the inflammatory remarks of the separatist like the accused.

6. That the accused No.1 made many other allegations as mentioned in the above paragraphs which is causing further hatred, enmity and violence in between the Kuki militants and Kuki civilians on one hand; and innocent Meitei community, on the other hand. It is submitted that the peaceful coexistence which existed in the State between Meitei Kuki militants and Kuki illegal immigrants from Myanmar who have come to Manipur in the last 30 to 40 years. That am a resident of Imphal East District and the downloaded copy of the interview of accused No. 1 and 2 with Wire News Chanel was assessed on 18/06/2023 through my phone at my office at Lamlong Bazar, Imphal East, Manipur.

That the accused No. 1 and 2 are stated to be a convenor, Kuki Women Forum and General Secretary, Kuki People Alliance respectively.

That the accused during the month of May-June, 2023 has given interview in the channel "Wire" with Karan Thapar regarding the current situation of Manipur which are very much defaming against the Meetei/Meitei Community and has also committed offence mentioned above.

That the accused No. I has stated in the above interview that the Meetei has pre-planned to kill Kukis and ethnic cleansing of Kuki on the valley area of Manipur. She even charged the Hon'ble Chief Minister of Manipur that he has preplanned the ethnic cleansing of Kuki on the valley area of Manipur. The very statement of the accused No. 1 is totally false and denied which are very much defaming against the Meitei Community. The accused No. 1 also gave statement that some cultural organisations of Manipur are the responsible organisation instigating the present violence which is totally false and denied and even more defaming to the Meitei community. The very statement of the Accused No. 1 is reproduced here below for easy reference;

"We don't trust Manipur Police. They have been their like all out helping the state sponsored armed militants-Arambai tengol and the Meitei Leepun"

The very statement of the accused No. 1 has brought more communal enmity during this burning situation in the State of Manipur.
