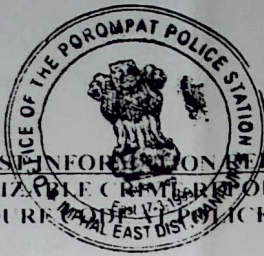

Once we moved out of the After some days they burned down our whole house we have to flee since we were kuki, we still fear our life. I am a student at Manipur Institute of Technology Imphal and now I don't know when I can go back to house and college. I had possessions including electronics vehicles and jewels worth Rs 90 lakhs i.e. 90,00,000 my house itself cost 2.50 crore (2,50,00,000) a CRUZE car MV 06L B 6307 EON: MN 015 4079 Accus - MN 012 4477 were a burned by Brambai Tengal. Due to the incident I a family members had been put to great hardship mental trauma. Hence I request that you will investigate the matter - proper action against the perpetrators as well as restore the situation to normalcy and provide protection for us to go back and re-build our lives back in locality. We are hoping for justice for us all
