Subject:- **Report on attempt to murder, assault, battery, criminal intimidation.**

Sir,

I, the undersigned, have the honour to state the following for your kind intervention and favourable action praying for registering an FIR and investigate the matter by due process of law:

1. That, I Shri. Seilunlal Haokip S/o Kakai Haokip, aged about 25 years, belonging to the Any Kuki Tribe tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**
2. That, I am working as an assistant at Galaxy Medicos situated at Tonglambi, P.O./P.S. Porompat, Imphal East, opposite to JNIMS campus, and at about 8:30 pm on the 3<sup>rd</sup> of May 2023, a large mob gathered in front of the said medicos belonging to meitei/meitei community suspected to be spearheaded by members of Arambai Tengol and Meitei leepun, chanting anti tribal slogan, without any valid reason, except solely by being from a Kuki Tribal Community I was mercilessly/brutally beaten with an intent to kill and was left for my fate on the spot itself. But fortunately, I survive the ordeal and was receiving medical treatment at KCC Imphal Hospital.
3. The said incident was also capture by the same miscreant and was uploaded on various social media platform which daunt and haunt me just by hearing the sound of it and left me perplexed and disturbed me to my very core.
