I, the undersigned, have the honour to state the following for your kind intervention and favourable action praying for registering an FIR and investigate the matter by due process of law:

1. That, I Shri Siehminthang aged about 24 Years of Age S/o S. Thangkhohao, belonging to the Thadou-Kuki tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**
2. That, I am a permanent resident of Chassad Avenue, P.O./P.S. Porompat, Imphal East, at present currently taking refuge at Head Quarter Veng, Churachandpur District, Manipur-795128.
3. That, on the 15<sup>th</sup> of May 2023, some armed radical mobs belonging to meitei/meitei community spearheaded by Meitei Leepun and Arambai Tengol armed with sophisticated weapons, accompanied by state forces posted at various valley based police outpost stormed into our residence and burnt all my property including one two wheller details of which are listed hereinunder;

Estimated to be at an amount of Rs. 94,000 was lost due to the illegal act of the said miscreant.

That, in view of the above stated facts and circumstances, being a victim of a communal/ethnic clash spearheaded by the majority meitei/meitei community, I am filing this report with a request to kindly take necessary legal action against the perpetrators as per law.

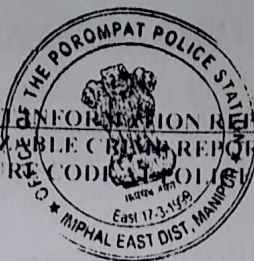
