I, the undersigned, have the honour to state the following for your kind intervention and favourable action That, I Nehthomony Hacker aged about 37 years, S/o(L) Jamkhaham belonging to the AKT tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that, I am a permanent resident of New Checken, P.O./P.S. Porompat District Manipur-795101 That, at about 7 am/pm on the 15 May 2023, some armed radical mobs belonging to meetei/mentei community spearheaded by Arambai Tengol and Meetei Leepun armed with sophisticated weapons, chanting anti-tribal slogan, barged into the village, and the said mob accompanied by state forces posted at various valley based police outpost destroyed, vandalized, looted and burnt/gutted my Proferties and all my household item/assets was all lost, a total loss estimated to be at an amount of Rs. 30 Lakk approximately.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at S. Molcham

Being a victim of ethnic attack by the dominant and majority Meiteis, I am filing this report with a equest to kindly take necessary legal action against the perpetrators as per law.
