Therefore I kindly request you to please take action in this matter and come up with positive solution.

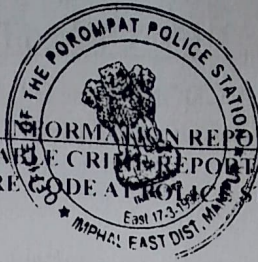




