Brief fact is that my sister namely Chiinsianching Khongsai who studied GNM (Medical Nursing)
at Nightingale Nurse Institute, PO- Porompat, PS- Porompat, District- Imphal East, Manipur was attack
by miscreant mob of Meitei Community on the 04-05-2023 evening around 4:46 PM stating and accused
her "an illegal immigrant from other country" and brutally physically assaulted, hit, punched and
thrashed her, they left her to die on the street. Some good Samaritan took her to the JNIMS Hospital
and she was admitted to ICU at JNIMS, Imphal and bed ridden for 3 days and 2 night.

During her struggle at ICU, JNIMS, Imphal no legal procedure has been followed and taken up.
Neither Medico Legal Case (MLC) was registered by the Concern Hospital nor was a regular FIR register
by the Concerned Porompat Police Station. Henceforth, no till date no intimation or inquiry has been
conducted by any Govt. agencies.

I, therefore, seek and prayed to your kind office to intervene and register a complaint/FIR
against the perpetrators, who carried such heinous crime against my sister and against the welfare
society at large.

Looking forward with your anticipation, I shall always remain grateful to you.
