The said unidentified groups vandalized/burnt down my rented room which is owned by Loitongbam Tilotama Devi of Ward No. 6, Moreh Bazar, Moreh and looted all valuable item. In the unfortunate incident, I have lost a total amount about Rs 1000000/- (Rupees Ten Lakhs) approx. . That, the incident was begin from 03/05/2023.

It is, therefore, requested to kindly take necessary legal action against the accused persons and the persons involved in the said inhuman acts and heinous crime according to law.
