I, the undersigned have the honour to state that large number of innumerable unidentified group of people belonging to kuki community with deadly weapons and sophisticated arms including kuki militant group(s) stormed to all Meitei inhabited area of Moreh town on 26/07/2023 from 9.30 am till 4.30 pm. The said unidentified group vandalized/burnt down my rented room which is owned by Loitongbam Tilotama Devi of Ward No. 6, Moreh Bazar, Moreh and looted all valuable item. In the unfortunate incident, I have lost a total amount about Rs 800000/- (Rupees Eight Lakhs) approx. . That, the incident was begin from 03/05/2023.

It is, therefore, requested to kindly take necessary legal action against the accused persons and the persons involved in the said inhuman acts and heinous crime according to law.
