Sir,

I have the honour to state that, 04/05/2023 at around 13:30 am some unknown miscreants suspected to be members of Meetei Leepun and Arambai Tenggol numbering carrying deathly weapons entered at my rented house at Porompat Kongkham Leikai Imphal East District, about 4 Km South from Saikul PS. In order to save my live I abandoned my rented house and fled to 2 MF Relief centre and now temporarily shelter at Saikul, Kangpokpi District. It is learnt that some unknown miscreants have vandalised my rented house and looted all the moveable and valuable properties and destroyed the remaining household items. The list of properties destroyed or loss are mentioned in the **Annexure (enclosed)**. The Approximate value of lost properties is calculated at about Rs. 13,27,500/- (Thirteen lakhs twenty seven thousand five hundred) only.

It is, therefore, requested to kindly register a case and take necessary legal action against the culprits according to law.


