Sir,

I have the honour to state that, on 04-05-2023 at around 11:30 am some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 900-1000 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality at Haokip veng, Palace compound about 45 Km South from Saikul-PS. They looted all the valuable and moveable properties and burnt down my house to ashes leaving us homeless.

The list of properties destroyed or lost are mentioned in the **Annexure (enclosed)**. The Approximate value of lost properties is calculated at about Rs. 4,50,000/- (Four lakh fifty thousand) only.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
