Subject: Report.

Sir,

I have the honour to state that, on 04-05-2023 at around 11:30 am some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 900-1000 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered our locality at Haokip veng, Palace compound about 45 Km South from Saikul-PS. They looted all the valuable and moveable properties and burnt down my house to ashes leaving us homeless.

The list of properties destroyed or lost are mentioned in the Annexure (enclosed). The Approximate value of lost properties is calculated at about Rs. 4,50,000/- (Four lakh fifty thousand)

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
