Due to the prevailing law and order situation I could not go back to my Hostel and also leave that my properties along with my vehicle was stolen by some unknown miscreant in collusion with the owner of the Hostel namely Kuljit Singh of New Checkon, Imphal East, Manipur.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
