I have the honour to state that, on the fateful night of dated 03-05-2023 at around 11:30 pm some unknown miscreants suspected to be a members of Meeitei Leepun, Kangleipak Kanba Lup, Arambai Tenggol, a Meitei Youth Organisation numbering about 800-1000 entered our locality New Lambulane 3<sup>rd</sup> Street Imphal East, PO: Imphal and PS : Porompat , Imphal East District, Manipur and forcefully looted all my household property including Scooter, Bike, furniture's etc. other household items namely - 1) Almira, Rice bags 400 Kgs, Rice mill, Tulu, Washing Machine, TV. 53 cm. Computer set, Blankets, Sofa Set, Dressing Table (2), Clothing items, Sewing machine, Gas Stop with 6(six) Cylinders, Dining table with 4 Chairs, Refregenerator, Utensil, Bed (10) nos, Sintex 1000 ltr 6 nos. The approximately value of the lost property is calculated at about Rs. 36, 98000,(Thirty six lakhs and ninety eight thousands).

It is, therefore, requested to kindly registered a regular case and take necessary legal action against the culprits according to law.

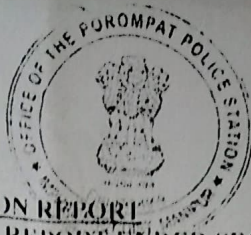


