Subject: Request for lodging of FIR case regarding looting and ransacking/burnt down of my house located at Moreh on 26th July, 2023.

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified group of people belonging to KUKI Community with deadly weapons and sophisticated arms including KUKI Militant Group(s) stormed to all Meitei inhabited areas of Moreh town on 26th July, 2023 from 10.00 a.m. till 4.00 p.m. The said unidentified groups vandalized my house and looted all the valuable items. In the unfortunate incident, I have lost a sum amount of about Rs. 51,52,410/-(approx.) and a house worth Rs. 1,20,00,000/- (one core and twenty lakhs) approximately, thus a sum amount of Rs. 1,71,52,410/- (One core seventy one lakhs fifty two thousand four hundred and ten) had been damage. That, the unfortunate incident had begin from 3rd May, 2023, thus, me and my family members were displaced to 5th AR at Moreh on the 4th of May, and at present are taking shelter at my relatives resident at Imphal. The incident happened while me and my family were staying at the said Imphal.

Therefore, I requested you kindly take necessary legal action against the accused persons that were involved in the said inhuman acts and heinous crime according to law.




