Sir,

With reference to the above cited subject, I have the honour to make this report to you for your kind and favorable and action please:

1. That, due to fear and intimidation by the majority Meitei's, our family left our home situated at **Gilgal, 3<sup>rd</sup> Street, New Lambulane, Imphal East-795005, P.O. & P.S.-Porompat, Manipur**, on 6<sup>th</sup> May 2023 at around 1:00 PM and took shelter at 1<sup>st</sup> MR leaving behind all our household items and belongings including certificates, other important documents and all our valuable assets.
2. That, we came to know from local reliable source that our home has been vandalized and looted on 27<sup>th</sup> June, 2023 at around 1:00 to 2:00 PM.
3. That, due to the ongoing ethnic cleansing spearhead by the majority meitei community, comprising of Arambai Tengol, Meitei Leepun within the valley district, I had no option to make a report at the Place where the incident occurred.

In the given circumstances, I humbly pray to kindly register an FIR, investigate into the matter and punish the perpetrator as per the prevailing provisions/ law of our Country. And for this act of kindness, I shall remain obliged and thankful.
