and looted.

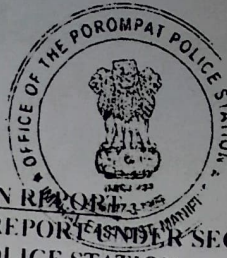
The reason for my late report was that I was kept
