I have the honour to report that today i.e. 07/08/2023 at about 04:30 am, while I along with a team of Porompat Police Station were patrolling in and around New Checkon area in that when we reached Mission lane. We saw a person coming out of an abandoned house with a bag in a suspicious manner. Seeing his suspicious manner we detained the person. On verification he identified himself as one Letminthang Paite (24) yrs S/o (L) Janglam of Singhat Zou Veng, PS- Singhat, Churachandpur-District.

On checking the detainee at the spot, 12 steel water tap was found from his bag. On enquiry, the said person disclosed that the said water tap was stolen from the abandoned house. Hence the said water tap was seized from his possession by observing necessary formalities at the spot at 04:40 am and he was arrested at 04:45 am.

It is therefore, the said accused person Letminthang Paite (24) yrs S/o (L) Janglam of Singhat Zou Veng, PS- Singhat, Churachandpur-District along with the seized items are handed over to OC/ Porompat PS for further necessary legal action.
