With due respect, I would like to report that I am the Proprietor /partners of Go Aviator Academy, Imphal Branch and our academy imparts aviation training to inspiring students.

- i. That the aforesaid Imphal Branch of the Academy was opened and inaugurated recently on October, 2022.
- ii. The Academy was operating and conducting training classes on the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> floor of the building standing on the land under patta no. 1418/2064 (new) covered by C.S. Dag No. 5657/5729 situated at Village No. 26(A) Nongpok Ingkhol at New Checkon, Imphal East District, adjoining the western side of the road leading to Checkon from palace compound the building is also popularly known as Khadims and Gaviator Building because of its showroom on the ground floor.
- iii. That the 3 (three) floors of the aforesaid building was taken on lease for 10 (ten) years by the undersigned from the owner of the aforesaid building namely Smt. Phairembam Indubala Devi of Uripok Takhellambam Leikai for running the aforesaid Academy.
- iv. That the third floor of the aforesaid building / class room was furnished on our own expenses with the following;
  - i. 100 pcs of student chairs, 4 pcs (set) of office chairs and table worth 5,00,000/-,
  - ii. false ceiling, AC and fan worth Rs. 5,00,000/- (Rupees Five Lakhs) only,
  - iii. Fibre board wall worth Rs. 200,000/- and
  - iv. Academy demo kit and equipment worth Rs. 300,000/- etc.
