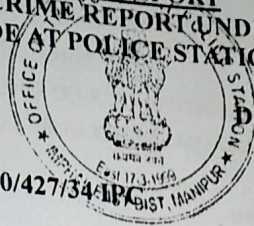
Subject: Report.
