from *9:30am to 2:00pm*. The said unidentified groups vandalized  
burnt down my house/Shop and looted all valuable items. In the unfortunate  
incident, I have lost a total amount about Rs. *4500000 forty five*  
Approx. That, the incident was begin from *3/5/2023*. So, I and my all family  
members are taking shelter at relief camp (Ideal Girls College) situated in  
Wampet Imphal East District, Manipur since *11 May, 2023*. That, the  
incident was happen while I and my family were staying at the said relief camp.

It is, therefore, requested to kindly take necessary legal action against the  
accused persons and the persons involved in the said inhuman acts and heinous  
crime according to law.
