The said unidentified groups vandalized/burnt down my house/Shop and looted all valuable items. In the unfortunate incident, I have lost a total amount about Rs. 25000.00 twenty five Approx. That, the incident was begin from 3/5/2023. So, I and my all family members are taking salter at relief camp (Ideal Girls College) situated at Akampat Imphal East District, Manipur since 11 May 2023. That, the incident was happen while I and my family were staying at the said relief camp.

It is, therefore, requested to kindly take necessary legal action against the accused persons and the persons involved in the said inhuman acts and heinous crime according to law.
