I have the honour to state that on 4/5/2023 around 11:00am some unknown miscreants belonging to Meitei Youth Organisation suspected to be members of Arambai Tenggol, Meitei Leepun and and Kangleipak Kanba Lup (KKL) , World Meitei Council(wmc) and Schedule Tribe Demand Committee(STDC) about 900-1000 members carrying sophisticated weapon like AK,Rifles,SLR and 303 Rifles forcefully entered my home located at Haokip Veng,Patta No.287 House No.3 Imphal East ,PO-Porompat , Imphal Manipur. They looted all the valuable household and burnt down to ashes leaving us homeless. The approximate value of the lost properties is Rs.2.75 Crores.

It is therefore , requested to kindly registered a regular case and take necessary action.

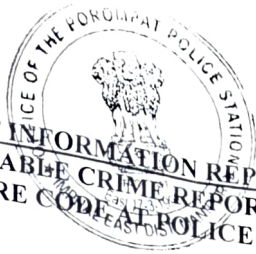
