I have the honour to state that, On 07-05-2023 at around 11:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality, New Lambulane, New Checkon, Imphal East District, Manipur, about 45 Km South from Saikul-PS and they vandalised my house and looted all the moveable and valuable properties including one Acura 5G bearing Regd. No. MN06SF 9238 and Yamaha Dio bearing Regd. No. MN03A 7235 AF Regd. No. MN 01 AN 1237 and burnt down my house along with all the remaining items into ashes leaving us homeless.

The list of properties destroyed or loss are mention in the **Annexure (enclosed)**. The Approximate value of lost properties is calculated at about Rs. 89,65,000/- (Eighty nine lakhs sixty five thousand).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.




