I have the honour to lay the following few lines for your kind information and necessary action on the above cited subject.


That on dated 26 July 2023 of around 4:30 PM a large number of people of Kuki community Leaded by Sh.Letpao Haokip Ho'ble M.L.A of Tengnoupal constituency along with kuki militants group viz K.N.O/K.N.A holding deadly heavily weapons and sophisticated arms have looted all my valuable household items along with Groccery shop (mixed items)and vandalized/burnt down the same house and shop. The brief description of my house is furnished as under. The house was built by wooden structure with ekra walling, and C.G.I roofing for a length of 75ff. and 15ff. width having four rooms and front varandah. The hotel and shop was also built by wooden structure with C.G.I. sheet roofing and ekra walling having a length of 40ff. and 12ff. width. I have lost a total amount of Rs 20,00,000/-(Rupees twenty lakhs)approximately in that unfortunate incident. After the outbreak of class/war all my family members had fleed/run away from Moreh and at present staying at a relief camp at Ideal Girl's college Akampat ,Imphal East district.

It is therefore requested to your goodself to kindly initiate necessary legal action against the accused persons/culprits involved in the said in human acts and heinous crime Committed by them as per law of the land at the earliest.

I shall be very grateful for your kind co-operation and necessary action in the matter Please with warm regards.
