I am a government employee serving as a Carpenter at Jail Department presently posted at Manipur Central Jail, Imphal of Manipur Police Department, Government of Manipur.

I have resided at Chassad Avenue near New Checkon, PO & PS- Porompat, District- Imphal East as a tenant due to my posting at Imphal. Wherein, I along with my wife, mother and 3 cousins have accommodated and live in.

I would like to inform and register a cognizable offence carried out against me at my residential house on the 4th day of May, 2023 around 10:00 AM, who were armed with sophisticated Pistol, Machette and Knife, whom were suspected to be instigated and abated by Meetei Leepun and Arambai Tenggol of Valley based CSO's.

Due to such attack and being in state of vulnerable. Fearing to lose our lives, I along with my family comprise of Male-2 & Female- 4 had fled from our resident.

As such, we have been taking shelter at the resident of my father in law namely Mangchon Sitlhou of B. Vengnom, Churachandpur District.

On inquiry, I came to know that the residential house where I live in as a tenant was ransacked and looted. Similarly, my Acura 6G bearing Regd. No. MN06SF1029, Engine No. JF91E00146859, Chassis No. ME4JF913CMD147646, Colour-Blue Mettalic, Mfg- Honda was also burnt down by the miscreants.

I, therefore, seek your kind intervention to register a complaint (Zero FIR) against the culprit and instigator who abate to carry out such heinous attack against me and my family for the end of justice.


