
Sir,

I have the honour to report that on 4/5/2023 due to ethnic/communal clash between Meiteis and Kukis, some unknown miscreants suspected to be Arambai, Tenggol, Meitei Leepun attacked my residential house at Haokip Veng, Mahabali near Boat, PS-Porompat, Imphal East District. The said miscreants burnt down my residential house along with many valuable household properties and looted away bike pulsar bearing registration no. MN04B-7834 and Scooty Vespa bearing registration no. MN01V-4269. Some important documents were also burnt down to ashes. The approximate cost of the loss properties is about 9,00,000/- (Nine lakhs).

It is therefore, requested kindly to take up necessary legal action according to law.


