As a result, all my valuable household properties were destroyed and looted including important documents. The approximate value of the lost properties is calculated at about Rs. 25 Lakhs.

It is therefore request to kindly register a regular case in your good office against the culprits according to the law.

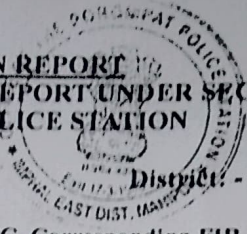
