That, on 4/5/2023 at around 9:00 Am a large number of miscreants suspected to be Arambai Tenggol and Meitei Leepun forcefully attacked our permanent residential at Chassad Avenue, Nongpok-Inkhol, PS-Porompat, Imphal East District with an intend to murder by carrying sophisticated weapons.

As a result, they destroyed our house, looted all our household properties and later burnt down the house including all our important documents. The destroyed and burnt down properties worth is estimated to be around Rs. 1.20 Crores. The cost of my residential plot of land bearing Pucca JamaBandi No. 1631 is estimated to be around Rs. 2 Crores.

Therefore, you are requested to kindly take necessary action at the earliest and for which act of kindness I shall remain ever grateful to you.
