Sir,

I, Nengngaikim Lhouvum, aged about 21yrs D/o Lunkhomang Lhouvum of K-Phoipi, Motbung village, Kangpokpi District would like to inform that I am a nursing student studying in 3rd year GNM in Nightingale Nursing Institute cum Hostel at Porompat, Imphal East. On 04.05.2023 at about 3:30-4:00pm Meitei mob miscreants consisting of Meira Paibis and Meitei men in black t-shirts stormed into our hostel by breaking into it and started searching for Kuki students. In course of their search two of our female hostellers namely, Miss Agnes Neikhohat Haokip and Miss Chinsianching Khongsai were abducted. However, I along with 4 (four) other female students managed to escape by hiding ourselves under three joint beds on the first floor of our hostel and later on escape through the back gate of the institute along with other Naga female hostellers under fearful circumstances as there was grave and strong apprehension of deadly attack on our life by Meitei mob as we belonged to Kuki Community.

I, therefore, request you to kindly register my complaint.

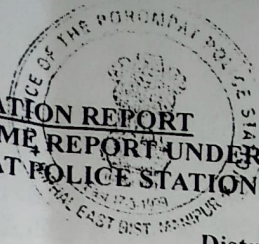




