That, I and my family members are victims of the pr
ent unrest that occurred from 03-05-2023 onwards. Presentl
I am taking refuge at moirang tumam leikai relief camp.

The unknown armed miscreants suspected of the kuki
tribe as they conversed among themselves in the kuki dialect
burnt down my house and destroyed my household property.
They attacked us with guns, stones etc. while running aw
from them I was hit on my Head by stones cause
serious injury.

Delay of filing an F.I.R is due to displacement and
uncertainty of relief camp.

In view of the facts and circumstances, I shall be
grateful if you kindly take necessary actions and app
hend the armed miscreants and punish them accord
to law.


