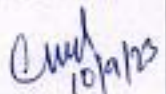

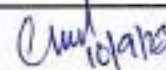

ent unrest that occurred for 03-05-2023 at uncontrolled relief
camp.

The unknown armed miscreants suspected of the led
tribe as they conversed among themselves in the kuki
dialect, burnt down my house and destroyed my house
old properties. They attacked us with guns, stones
etc. while running away from them I was hit on my

leg (right) by stones causing serious injury.
Delay of filing an F.I.R. is due to displacement and un
certainty of relief camp.

In view of the facts and circumstances, I shall be
greatful if you kindly take necessary action and app
hend the armed miscreants and punish them accordi
ng to law

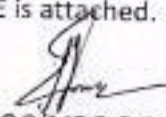

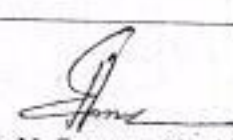
