Sir,
I, the undersigned beg to report for your kind and necessary
action.

That, I and my family members are victims of the present
unrest that occurred from 03-05-2023 onwards.

On 3rd May around 8 pm, while I was at home along with
my family members consisting of me and my wife, children and
other family members. Some unknown armed miscreants attacked my
house, physically assaulted us and destroyed household properties
worth approximately ₹ 10,50,000/- (Ten lakhs fifty thousand only).

That, the unknown armed miscreants suspected to be of the
Kuki tribe as they conversed among themselves in the Kuki dialect
while assaulting us. The said unknown armed miscreants also
set on fire and burned down my residential house, including
two maruti car, one ecovan and other valuable household items
which are given in the list enclosed along with the report.

The unknown armed miscreants warned and threatened
my family and me to leave the village permanently and that
we will face dire consequences if we return to the village again.

Delay in filing an F.I.R is due to displacement and uncertainty
of relief camp.

In view of the facts and circumstances, I shall be grateful
to you if you would initiate appropriate steps to identify and
apprehend the miscreants and punish them according to law.

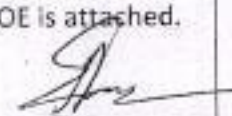
