Sir,

I, the undersigned beg to report for your kind and necessary actions

That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.

That, on 3rd may around 7:40 pm. while I was at home along with my family consisting of my wife and son, some unknown armed miscreants attacked my house. physically assaulted my family and destroyed household properties worth around ₹ 6,00,000 (Six lakhs) approx.

That the unknown miscreants suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while assaulting us. The said unknown armed miscreants also set on fire and burned down my residential house, furniture and other valuable household items which are enclosed in the list along with the report.

The unknown armed miscreants warned and threatened me and my family to leave the village and that we would face dire consequences if we return to our village again.

Delay in filing an F.I.R is due to displacement and uncertainty in relief camp.

In view of the facts and circumstances I would kindly like to request to you to identify and apprehend the unknown armed miscreants and punish them in accordance with the law:

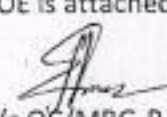
