With due respect, I, the undersigned, namely
Naorem Bina Devi aged 68 years, resident of
Zouvang Ichugatampak, CPUR beg to submit the follow-
ing few lines for your kind consideration and necessary
action.

- A. That, I and my family members are victim of the
present unrest that occurred from 03-05-2023 onwards
- B. That on 4/5/23, at about 11:35 am, some unknown person
numbering about 400 belonging to kuki community started attacking
the undersigned along with my children and other family
members; some unknown armed miscreants attack my house
physically assaulted my family members including myself
and destroyed household properties worth Rs. 4,00,000
(Four lakhs) approximately.
- C. That, the unknown miscreants are suspected to be of -11
Kuki dialect while physically assaulting my family and

.D. That the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequence if we return to our village again. Do of filling FIR is due to displacement and uncertainty of relief camp. In view of the fact and circumstances I shall be very grateful if your good self would kindly initiate appropriate step for identifying the unknown arm miscreants, apprehend them and punish them according to law.
