I, the undersigned beg to report for your kind
and necessary action.

I. That I and my family members are victims
the present unrest that occurred from 03-05-20
onwards!

II. That, on 05-05-2023, at about 8:30 pm, s.
Unknown person numbering about 70 belonging to
kuki community started attacking the undersigned
along with family members including myself and
destroyed household properties worth around Rs.
15,00,000 (Fifteen lakhs) approximately.

III That, the unknown miscreants are suspected to
be of the kuki tribe as they conversed among

themselves in the kuki dialect while physically assaulting my family and destroying my household properties. The said unknown armed miscreants set on fire and burned down my residential house, non private vehicle and other household items which are given in the list enclosed along with this report.

IV That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of FIR is due to displacement and uncertainty of relief camp place. In view of the facts and circumstances, I shall be very grateful if your good self would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.
