I, the undersigned beg to report for your kind and necessary action
that I and my family members are victims of the present unrest
that occurred from 03/05/2023 onwards.

On 3rd may around 9 pm. while I was at home along with
my family members consisting myself, my wife and children.
Some unknown armed miscreants attacked my house, physically
assaulted us and destroyed household properties worth around
₹ 26,00,000/- (Twenty six lakhs) approximately.

That the unknown miscreants, suspected to be of the Kuki
tribe as they conversed among themselves in the Kuki dialect
while physically assaulting us. The unknown armed miscreants
also set on fire and burned down my residential house,
a Baleno Car (MN 01 AS 0019), Activa 5G (MN 02 4108) and other
valuable household properties which are enclosed in the list
along with this report.

That, the unknown armed miscreants warned us to
leave the village permanently and that we would face dire
consequences if we return to our village again.

Delay of filing an F.I.R. is due to displacement and
uncertainty of relief camp.

In view of the above facts and circumstances, I shall be
very grateful to you if you would kindly initiate appropriate
steps to identify and apprehend the miscreants and punish in
accordance with the law.
