Respected Sir,

I, the undersigned by to report for your kind necessary action.

1. That I and my family members are victims of the present unrest that occurred from 3-5-23 onward.
2. That on 3rd, May 2023 at around 7:30 pm, while I was at home along with my family members consisting of myself, my wife and other family members, some unknown armed miscreants attacked my house. Physically assaulted my family members including myself and destroyed household properties worth around Rs. 75 lakh (seventy five lakh) approximately.
3. The said unknown armed miscreants also set on fire down my residential house and private vehicle and other household items which are given in the list enclosed along with the report.
4. That the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently, and that we will face dire consequence if we return to our village again. Delay of filing a FIR is due to displacement and uncertainty of relief camp.

In view of the facts and circumstance, I shall be very grateful. If your goodness would kindly initiated appropriate steps for identifying the unknown armed miscreants, apprehend them and punish them accordance with law,
