Respected Sir,

I, the undersigned by to report for your kind and necessary
action.

That, I and my family members are victims of the present unrest
that occurred from 03-05-2023 onwards.

That, on 3rd May 2023 at around 7:30pm. while I was at home along
with my family members consisting of my self, my children and
other family members some unknown armed miscreant attack-
ked my house physically assaulted my family members includ-
ing myself and destroyed household properties worth around
Rs 25,00,000+ (Twenty five lakhs only). That, the unknown miscre-
ants are suspected to be the Kuki tribe as they conver-
sed among themselves in the Kuki dialect while physically
assaulting my family and destroying my household properties.
The said unknown armed miscreants also set on fire and
burned down my residential house, and other household
items which are given in the list enclosed along with this
the report.

That, the unknown armed miscreants warned and threatened
my family members and myself to leave the village per-
manently and that we will face dire consequences if
we return to our village again. Delay of filling an F.I.R.
due to displacement and uncertainty of relief camp/place
In view of the facts and circumstance, I shall be very grati-
fied if your goodself would kindly initiate appropriate
steps for identifying the unknown arms miscreants app-
rehend them and punish them in accordance with law.

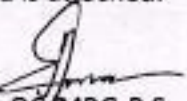
