Respected Sir,

I, the undersigned beg to report for your kind and necessary action.

1. That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.
 2. That, on 03-05-2023 at around 8:00pm while I was at home along with my family members consisting of myself, my wife, childrens. Some unknown armed miscreants attacked my house, physically assaulted my family members including myself and destroyed household properties worth around Rs 15,00,000 (Rupee. fifteen lakhs only) approximately.
 3. That, the unknown miscreants are suspected to be Kuki tribe as they conversed among themselves in Kuki dialect while physically assaulting my family and destroying my household properties. The said unknown armed miscreants also set on fire and burned down my residential house. Destroy 125 (Vx) MN06SG8909 Private vehicle and other household items which are given in the list enclosed with this report.
- That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and uncertainty of rel of comp / place

In view of the facts and circumstance, I shall be very grateful if your goodness would kindly initiate appropriate steps for identifying the unknown armed miscreants apprehend and punish them in accordance with law.

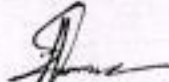
