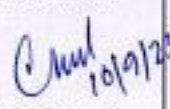

Respected Sir,

I, the undersigned beg to report for your kind and necessary action.

I. That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.

II. That on 04-05-2023, at about 7:30pm. While I was at my home along with my family member, consisting of myself, my wife, children and other family members, consisting some unknown armed miscreants attacked my house, physically assaulted my family member including myself and destroyed household properties worth around Rs. 5,11,000 (Five lakh eleven thousands) approximately.

Round 11 11.

That, the unknown miscreants are suspected to be of the kuki tribe as they conversed among themselves in the kuki dialect while physically assaulting my family and destroying my household properties. The said unknown armed miscreants also set on fire and burned my residential house, non private vehicles and other household items which are given in the list enclosed along with this report.

IV That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequence if we return to our village again. Delay of FIR is due to displacement and uncertainty of relief camp place. In view of the facts and circumstances I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown armed miscreants, apprehend them and punish them in accordance with law.
