Sir, I, the undersigned beg to report for your kind and necessary action.

That me and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.

On 3rd may 2023 at around 8 pm while I was at my home along with my family some unknown armed miscreants suspected to be of the Kuki Tribe as they conversed themselves in the Kuki dialect. They started destroying our household properties and attacked us with sticks, stones, guns. While running away from them I was hit by a stone on my leg causing serious injury and we are in a mental trauma now. They were trying to take our life / to cause serious damage to us.

Delay in filing an F.I.R is due to displacement, injury and uncertainty of relief camp.

In view of the facts and circumstances, I kindly request you to take up the necessary actions to identify and apprehend the armed miscreants and take the necessary actions
