Respected Sir,

I, the undersigned beg to report for your kind and necessary action.

That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards. Presently I am taking refuge at Moirang Kumam Leikai relief camp.

The unknown armed miscreants suspected of the Kuki tribe as they conversed among themselves in the Kuki dialect, burnt down my house and destroyed my household properties. They attacked us with guns, stones etc. while running away from them I was hit on my hand by stones causing serious injury.

Delay of filing an F.I.R is due to displacement and uncertainty of relief camp.

In view of the facts and circumstances, I shall be grateful if you kindly take necessary actions and apprehend the armed miscreants and punish them according to law.


